IN THIS TOGETHER

a message from Anne Richards, Goodwill President and CEO

It was March 20 when the leadership team at Goodwill and myself had to share the unsettling and surreal news that we would be closing our stores and furloughing nearly 700 members of our Goodwill family. Since that time, our lives and our agency have been turned upside down.

2020 has been a year of triumphs and struggles, yet through it all, Goodwill Industries of Greater Cleveland and East Central Ohio has continued to deliver on its mission of serving the needs of our community. Despite the shutdown, we continued to provide our mission to thousands of individuals throughout the 10 counties we serve. Some services, like The Ken Weber Community Campus at Goodwill and COMPASS Rape Crisis Services, experienced an increased demand during shutdown.

So often, we think of people who receive services from agencies like Goodwill as 'others.' One thing the COVID pandemic has taught us, is that we are all in need sometimes of support and care. Individuals and families in our own neighborhoods found themselves suddenly in situations where they needed a solid hand-up, supporting them as they work to improve their lives and the lives of their families. And, just as Goodwill has done for more than 100 years, where there was a need, we answered the call.

We have struggled. But together with our staff, leadership and community, Goodwill has weathered this storm and continued to strive. As we continue to maneuver the challenges of this difficult time, I rest easy knowing that with your support, with our outstanding staff and our clear focus on our mission, Goodwill is sure to excel into the future.

GOODWILL'S PANDEMIC JOURNEY

Unlike many other non-profits whose funding may not have been affected immediately during the pandemic, Goodwill's primary source of revenue, our retail stores, were shuttered for nearly three months. Despite this, mission outreach continued.



MARCH 2020

By state mandate, all Goodwill stores and donation centers are closed. Nearly 700 staff are furloughed. The agency's primary source of revenue to provide mission outreach comes to a halt.



APRIL - MAY 2020 Despite store closures, Goodwill continues to provide mission outreach. The Ken Weber Community Campus remains open. Services like COMPASS Rape Crisis begin to see increase in demand.



MAY 2020 State and local health departments allow Goodwill to open donation centers. Overwhelming amount of donations received during this time. Staff begin to be called back from furlough.




JUNE 2020

Goodwill opens the remainder of its stores and begins selling to the public again with safety precautions in place for staff and customers. Store traffic down 15-30%.

THE RETURN OF RETAIL

Late May and early June, Goodwill's retail stores reopened with safety precautions in place for both staff and customers. Working at the stores presented new challenges, but the Goodwill team members adapted well to this new way of doing business. Since reopening, customer traffic has decreased since before COVID, but sales remain strong at most locations.

donor spotlight

As the state of Ohio continues its economic recovery amid the COVID-19 pandemic, Gov. Mike DeWine announced a new program which seeks to help Ohioans who are looking for a job to have a better chance at finding that job.

The 'Ohio To Work' initiative led by JobsOhio, the Ohio Department of Jobs and Family Services, in association with Goodwill Industries and Urban League of Greater Cleveland brings together employers, nonprofits, educators, and training providers to help Ohioans reskill and restart their careers. The program was launched in Cleveland/Cuyahoga County, and will expand to more areas of the state.

Ohio To Work will help someone who is out of work to identify a new career opportunity, train for it, and then be placed with an employer. Already, more than 30 employers have signed on with the initiative.

Goodwill

Tucked away in a small church just off the highway in Weirton, West Virginia is hope....Table of Hope, that is. This hot meal program has served the most basic needs of Hancock and Brooke Counties in West Virginia since 2012.

Changes to their operations had the staff and volunteers of this vital program wondering if the outreach could continue without outside support. A happenstance meeting of Goodwill staff and participants, though, changed everything. At the beginning of 2020, Table of Hope became a program of your Goodwill.

Typically, Table of Hope serves two hot meals weekly, Mondays and Wednesdays. There is no cost and no questions asked of those in attendance.

COVID-19 restrictions temporarily closed the program, but in September, they were able to reopen with limited hours and safety precautions in place.

Table of Hope is operated with support from volunteers, local businesses, donors and, now, Goodwill Industries.
